The attention of all the Correspondents of Un-aided Recognition Schools (PS/UPS/HS) in the district is invited to the reference cited and they are informed to observe the following instructions scrupulously..

1. The Management shall conduct the meeting with the Governing Body members before re-opening of schools to discuss about collection of fees as per Governing Body Resolution and other items.
2. The Fee Structure shall display in the School Notice Board.
3. The Management shall follow the pay structure / fee structure fixed by the Government Body shall be got approved by the DEO every year.
4. School vehicles shall maintained as per the instructions of the R.T.O concerned.
5. The Management shall Maintain Fire Safety measures in the school building premises as per the instructions of the D.F.O.Khammam.
6. The Management shall take admissions without any entrance test.
7. The Management shall arrange the first aid kit and one teacher shall be trained in First Aid.
8. The Management shall provide the safe drinking water in the school premises.
9. The Management shall not open the additional sections without prior permission from the higher authorities.
10. The Management shall not use associative words in the school name such as "IIT / Olympiad / Concept / E-Techno / E-Shastra / Convent and Public.
11. The Management shall follow the curriculum, syllabus and textbooks developed by State Government under RTE.
12. The Management shall follow the RTE Act 2009 Norms scrupulously.
13. The Management shall not sell Text Books, Note Books and school bags, shoes etc., in the premises.
14. The Management shall appoint the qualified staff as per RTE and should obtain qualification and keep them as record.
15. The Management shall follow the instructions issued in G.O.Ms.No.1/Edn, Dated.01-01-1994 and its subsequent amendments from time to time.

All the Dy. Educational Officers and Mandal Educational Officers are requested to see that no unrecognized school shall run in their jurisdiction and to publish the list of such schools in press and display on their notice boards, duly appealing the parents to not to admit their wards in such Un-recognized schools. They are further requested to take necessary action against the management of such un-recognized schools, as per the rules and to submit ATR to the undersigned.

Any deviation in the matter will be viewed seriously and the must held responsible for any lapse in the matter.
